Show Hall: Ross Norton Recreation & Aquatic Complex, 1426 S Martin Luther King, Jr. Ave. Clearwater, FL This is a climate controlled show hall.

Show Motel: Holiday Inn Express, ICOT Center; 13625 ICOT Boulevard, Clearwater FL 33760. Ph: 727-536-7275 Rate is \$69, plus 12% tax Free Breakfast, no cat fee. Call by 9/12/2008 refer to RAG. This is a new hotel for us. Please be mindful of how you leave the rooms when you check out!

Show Hours: Check-in & benching will be from 7:00am - 8:00am. Judging will begin promptly at 8:30 am. Advertised hours are 9:00 am - 4:30 pm, both days.

Check-in: This is a non-vetted show. All cats must be checked in through the show committee on BOTH DAYS. It is required that all shots be current and given at least two weeks prior to the show. All claws must be clipped. Kittens must be four months old to be in the show hall.

ALL PIXIE BOBS, BENGALS, KORATS, SINGAPURAS AND NBC'S MUST HAVE A REGISTRATION NUMBER PRIOR TO ENTERING THE SHOW!

SHOW RULES: This show will be governed by all ACFA Show Rules & Bylaws. These may be obtained by sending \$7.50 to: ACFA Central Office, P.O. Box 1949, Nixa, MO 65174.

NOTE: All cats **MUST** be accompanied by the owner or designated agent.

LIABILITY: Although Ragamuffin Associated Group takes every possible care, neither it nor the Show Management can be held liable for the loss of property or accident to the cats or exhibitors.

VETTING: All cats/kittens must be vaccinated two weeks prior to show time for your safety and the health of the cat. Any cats showing signs of being ill will be asked to leave the show hall and required to be examined by a veterinarian prior to being allowed back into the show.

AWARDS: Rosettes/Buttons will be awarded in all rings as specified by ACFA show rules. Cash donations to the award fund will be greatly appreciated and acknowledged in the show catalog. Permanent flats will be used for class and breed wins. <u>Registered cats</u> with their number in the catalog will be scored for ACFA Regional and Inter-American awards. Call ACFA today to register your cats: (417) 725-1530. Best of the Best will be awarded.

CAGES/NOVICE EXHIBITORS: Bring grooming aids and curtains or towels for the cages, which are about 24" deep, 24" wide and 22" high.

LITTER AND FOOD: Litter will be furnished. Litter pans will <u>not</u> be provided. Cat food will be furnished as donated. For people, a food concession is available outside the show hall.

HOUSEHOLD PETS (HHP): Household pets will be judged in all rings. Kittens will be judged with adults in all rings. Please indicate if your HHP is long or short haired. Per show rules, HHP kittens, 4 months to 8 months of age, may be altered or unaltered. Adults, 8 months and older, must be altered for registration and show. Any entry that is known to be of non-Felis Catus ancestry will not be permitted to be entered into the show.

TRANSFERS: Transfers will be accepted by the Master Clerk during the show on Saturday and prior to judging on Sunday. No transfers will be accepted on Sunday after judging begins. Bring information from your prior wins.

CLERKS & STEWARDS: We will pay clerks \$25/day. Stewards are paid \$10/day. Please, indicate on your entry form if you would be willing to clerk or steward. Submit entry forms and fees for all cats. We will notify you if you are needed to clerk or steward. You will be paid after the show. Lunch and beverages will also be provided. We need and appreciate you!!

ADVERTISING: Non-commercial rates on summary. Enclose sharp black & white copy with entry. You may sponsor a ring of rosettes for \$100 per day. Your donation will be acknowledged in the ring of your choice and in the catalog. Please contact the show manager immediately if you are interested.

VENDORS: A limited number of sales booth spaces are available (8 foot table area). No one is permitted to sell anything from theirs cages. Contact the show manager.

SALES CAGES: These are available for breeders who are also exhibiting cats or kittens at this show. No kittens or cats may be sold from carriers beneath the benching area. All kittens must be 4 months old to be in the show hall. We support serious breeders and it is suggested that no purebred kittens be sold in the show hall for less than \$150. All cats and kittens offered for sale must have valid <u>STATE OF FLORIDA HEALTH CERTIFICATE</u>. Ragamuffin Associated Group encourages spay/neuter agreements for all pets.

SPECIAL NOTES: While well-behaved children are welcome, a cat show can become boring for little ones. We urge exhibitors to make other arrangements for their children.
